

Fabriquick Terms and Conditions for External Providers

Contract Confidentiality: All information in the contract must be held in confidence and no third party request for information will be authorized unless instructed in writing by a Fabriquick representative.

Contract Changes: Any changes to the contract requirements by the supplier must be approved by Fabriquick in writing.

Right of Entry: In addition to Fabriquick's right of entry, the supplier agrees to the right of entry for our customers, or regulatory agencies, to all facilities and records in the performance of this contract.

Shipment Delays: Any delay in shipment must be conveyed to Fabriquick as soon as the delay is known. Fabriquick reserves the right to terminate the PO without liability if a revised schedule cannot be agreed upon between all parties.

Supplier Performance Expectations: Supplier on-time delivery and quality expectations are 90% or greater.

Nonconforming Product: Notify Fabriquick quality department of nonconforming product, and make proper arrangements for disposition.

Changes: Notify Fabriquick of changes in product and/or process definition and, where required, obtain Fabriquick's approval.

Transfer of Work: Notify Fabriquick quality department prior to transferring any Fabriquick work to a new facility. Fabriquick management will determine, prior to the transfer, if the supplier may perform the transfer of work.

ITAR: Suppliers shall protect all technical drawings/data provided with the purchase order in accordance with the International Traffic in Arms Regulations (ITAR) and U.S. export control laws.

Foreign Object Debris (FOD): Suppliers shall be compliant to all AS9146D FOD requirements.

Record Retention: Maintain adequate records of all inspections and tests. Records shall be kept for a period of twenty (20) years after final payment for supplies or services. After expiry, you should send us the documents in PDF format.

Latest Revisions: Unless otherwise specified by the purchase order, the supplier shall furnish and certify goods and/or services to the latest revision of applicable standards and specifications. This applies to customer specifications as required by the Fabriquick's purchase order. Suppliers shall contact Fabriquick to verify latest revisions of customer specifications as required.

Counterfeit Prevention: Suppliers shall purchase all products directly from the original equipment/component manufacturer (OEM/OCM), OEM/OCM approved distributors, or reseller supplier who must provide full traceability back to the OEM/OCM. Electronic components shall ONLY be purchased directly from the OEM/OCM or their authorized representatives and/or distributors.

Product Safety: Supplier agrees to be aware that their contribution to our products and/or services have a direct impact to the overall conformity and safety of our products and/or services.

Traceability: The supplier shall supply certification that clearly shows the complete chain of custody from the raw material manufacturer(s) through the finished product, including all processing, heat treatment, chemical processing, and inspections as required by the applicable specification requirement. All material and/or product must have full traceability from the mill or manufacturer through all distributors, if applicable, to Fabriquick's PO.

Notice of Escapement (NOE): Supplier shall inform Fabriquick within 24 hours of discovery of suspect nonconforming product having been shipped regardless of destination.

Ethical Behavior: Suppliers shall practice ethical behavior in order to ensure product safety and conformity. Honest and ethical recording and reporting business practices shall be used and through the submission of a Certificate of Conformance, certify the product meets the requirements of the purchase order, and is accurately and properly represented as such.
